Initial Details of Incident:

Child Bonded Labor, Domestic violence, Rape & Murder Case(16-08-2023): A Child Bonded Labor, Domestic violence, Rape & Murder case has been reported at Ranipur city Taluka Sobhodero District khairpur on 16-08-2023. According to the details a 10 years old girl Fatima Phuriro has been subjected to sever domestic violence, torture, insult & physical abuse that caused her death at the alleged Haveli of Pir of Ranipur, where the little girl used to work as a maid servant. She belonged to the village Ali Mohammed Phuriro near khan wahan Taluka Sobhodero. The girl used to work at the Haveli of Pir of Ranipur for the last 08 months & was from a poor family. Afterwards a video went viral on Social media wherein the girl could be seen in a fainted & probably in a naked condition and was heaving her last sight & finally died. The Social Medical sources suspected that the girl has been severely tortured & raped at the bed room of the alleged Pir, where she used to work. However the relatives of the victim girl told the media that today in the morning they were informed about the death of their girl child. Though the Rape allegations have yet to be ascertained & verified, but the case clearly is of Child Bonded Labor & severe domestic violence as that of a maid servant in Islamabad at the hands of wife of Judge. The Investigation is underway for the further verification, however the Police has not yet arrested the accused culprits under all those allegations. The case is a test case for SSP khairpur Mir Rohal khan khoso sahb. The Initial Report of the incident is thus submitted for your kind information and perusal please. the accused culprit Asad Shah Jillani was produced before Judicial Magistrate Sobhodero at Ranipur court by the police authorities Ranipur. The accused person Asad Shah after necessary proceedings was handed over to the police authorities Ranipur for 04 days remand for further investigation in the case.

Today the said accused Hina Shah Jillani has been granted surety bail /interim bail in the same case by Sindh High Court bench Sukkur. It is pertinent to mention here that Hina Shah Jillani is the wife of accused Asad Shah & she is referred as the real character behind all this domestic violence on the child as maintained by parents of victim Fatima Phariro. The further investigation of the incident is underway by the police authorities to make sure every possible aspect of the case. The concerned SHO Ranipur police Mr Ameer Ali Chang has been suspended by the DIG

Police Sukkur for hushing up the case & not informing the senior authorities about the case in time. The concerned Doctor who tried to cover up the case in the Gastro disease is also under arrest for the investigation purpose along with the SHO Ranipur Ameer Ali Chaang.

Follow up (17-08-2023)

According to the latest developments in the case of innocent victim Fatima Phariro D/O Nadeem Phariro, the accused culprit Asad Shah Jillani was produced before Judicial Magistrate Sobhoderro at Ranipur court by the police authorities Ranipur. The accused person Asad Shah after necessary proceedings was handed over to the police authorities Ranipur for 04 days remand for further investigation in the case. On the other side, an other nominated accused in the FIR Hina Shah alias Sonia shah couldn't be arrested last night even after the raid of the police on the alleged Haveli of Pirs. Today the said accused Hina Shah Jillani has been granted surety bail /interim bail in the same case by Sindh High Court bench Sukkur. It is pertinent to mention here that Hina Shah Jillani is the wife of accused Asad Shah & she is referred as the real character behind all this domestic violence on the child as maintained by parents of victim Fatima Phariro. The further investigation of the incident is underway by the police authorities to make sure every possible aspect of the case. The concerned SHO Ranipur police Mr Ameer Ali Chang has been suspended by the DIG Police Sukkur for hushing up the case & not informing the senior authorities about the case in time. The concerned Doctor who tried to cover up the case in the Gastro disease is also under arrest for the investigation purpose along with the SHO Ranipur Ameer Ali Chaang. The Child Protection Officer CPU Khairpur Qamar Uddin Channa & Assistant Director Social Welfare Department District khairpur Zulfiqar Shaikh paid visit to the affected Family at their village in khan wahan District Naushehro Feroz & offered condolences on the tragic demise of the innocent Fatima & assured Family of every kind of possible legal & moral support in the case. The father of the victim Fatima demanded the impartial & fair enquiry in the case & asked for the immediate post mortem of the victim Child to discover further facts related to the murder. They all strongly demanded a Judicial Enquiry into the matter & the lab tests from Agha Khan Forensic or LUMS Hospital Lahore as they suspected that accused culprits being influentials would get the medical results altered at the local levels as they have far reaching political influence every where. The victim Family also complained of the threats & intimidation on the part of accused party who harrass & pressurize them to back out of the case or take money in return for the murderd victim. The undersigned assured the victim Family for every possible support in the case. However being a poor Family they need immediate financial support or Ration support for their daily livelihood, that we request SCPA to arrange for it to hand them over in the next visit. However, we have also mobilized some NGOs on the local level to support this Family and also arrange for the education of their other children. The Father of victim broke into tears while narrating the story of his deceased girl child & requested the undersigned to provide justice to the innocent soul with his joint hands at me. It was really a moving & an emotional scene that moved all the audience at the village. INSHALLAH, on the next visit, the undersigned would provide the food & ration items to the Family for their support because the Family seemed extremely poor having even no fair to take the body of their daughter from Ranipur to khan wahan. I again request worthy DG SCPA to gather logistic support for the Family in the form of ration items to hand them over in next visit. The Follow up(1),Report is thus submitted for your kind information and perusal &, the updates will be shared with your good self from time to time.
